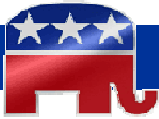

PRESIDENT'S MESSAGE

This past month we witnessed the importance of having a Republican in the Governor's seat. **Governor Sandoval vetoed numerous**

bad bills that would have turned Nevada towards the radical left side of the political spectrum. Our Governor even made the front page of the *Wall Street Journal* for vetoing a measure that would have flooded our State Medicaid system with new enrollees – at catastrophic expense to Nevada taxpayers and at odds with federal Medicaid rules.

A big thank you to everyone who called the Legislature, the Governor, and submitted comments on-line asking for vetoes! And a particularly big thank you to **Patricia Moser Morris** for sending out informative legislative updates.

On behalf of our Club, I sent a note to **Assemblywoman Lisa Krasner** thanking her for following her conservative principles and voting “no” on hundreds of bills that created wasteful new government programs.

In mid-June **Ms. Randi Thompson**, the Nevada lobbyist for the National Federation of Independent Businesses, gave us a blunt summary of the 2017 Legislature and how bad it was for business people and the economy. She particularly thanked Governor Sandoval for vetoing a major minimum wage increase (to \$14 an hour) that was passed by the Democrats. DESPITE SNOW A DAY EARLIER, over 50 of us came out to hear Randi and enjoy a delightful sunny evening in the garden of **Ellie and Cliff Dobler** with a delicious catered dinner.

Cliff Dobler also gave us some important background about a controversial measure for IVGID to take over the Parasol Building at an estimated cost of \$5.5 million to those who live in this community. By the time you get this newsletter, you will know we rode in the float and marched in the

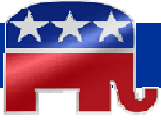

About our Speaker,
Michael Roberson



In 2010, Michael Roberson was elected to the Nevada State Senate and he was re-elected with over 60 percent of the vote in 2014. During the 2015 Legislative Session, Republicans were in the majority and his colleagues elected Michael to be

Majority Leader. Working closely with Governor Brian Sandoval, Michael helped enact the first universal school choice program in the country, revamped Nevada's economic development programs, invested more money in education, consolidated government agencies and regulations, and saved taxpayers' money with collective bargaining and PERS reforms.

During the 2017 Legislative Session, Michael served as Minority Leader, and in this role, worked with his Republican colleagues to prevent the Democratic majority from enacting many of their most damaging proposals into law; and to protect many of the accomplishments of the 2015 Legislative Session.

Michael has served on the Spring Valley Hospital's Board of Governors, the Advisory Board of Advanced Technologies Academy, the Government Affairs Committee of the Southern Nevada Chapter of NAIOP/ Commercial Real Estate Development Association and the National Conference of Commissioners of Uniform State Laws.

In 2012, *Governing* magazine recognized Michael as one of the 12 state legislators nationwide to watch. Last year the National Coalition for Capital awarded Michael the 2013 Champion of Small Business Award (COSBY) in recognition of the New Nevada Markets Jobs Act, which he sponsored.

Born in Webb City, Missouri and raised in Galena, Kansas, a small mining town with a population of 3,300, Michael grew up the eldest of three children. After high school, Michael entered the University of Kansas and graduated in 1993 with a degree in Political Science. From there, on academic scholarship, he was admitted to University of Kansas School of Law and earned his Juris Doctorate in 1996.

In 2000, Michael moved to Nevada. He is currently an attorney with the law firm of Kolesar & Leatham.

Michael is a University of Nevada, Las Vegas Rebels and Kansas Jayhawks football and basketball fan. He lives in Henderson with his wife, Liberty Leavitt-Roberson, a fifth-generation Nevadan, who is the Graduation Initiative Coordinator for the Clark County School District, as well as with their dogs, Winston and Franklin.

Liberal Agenda Blocked by Nevada GOP Legislators

During the 2015 legislative session, Republican legislators and Gov. Brian Sandoval successfully implemented many significant, cost-saving reforms. However, when Democrats recaptured majorities in both houses after the 2016 election, they were determined to roll back our reforms, while proposing what many have labeled the most liberal agenda ever proposed in State history.

Yet, despite their best efforts, Nevada Democrats failed to implement their agenda. In fact, conservatives have much to celebrate following the conclusion of the session considering we were in the minority in both houses.

Allow me to elaborate . . .

Important, cost-saving reforms relating to construction defect, collective bargaining, prevailing wage, and project labor agreements, among others, were all targets of liberal legislators. Fortunately, legislative Democrats failed on every single effort.

Further, in 2015, Republicans passed two critically important school choice measures – Education Savings Accounts (ESAs) and Opportunity Scholarships. Despite fierce opposition from the Democrats, both of these historic programs were signed into law.

Not a single Senate Democrat voted in favor of either of these programs in 2015, yet, Senate Democrats voted unanimously with Republicans this year to triple our state's investment in the Opportunity Scholarship school choice program. And while I am deeply disappointed that the ESA program remains unfunded, we did significantly expand school choice in Nevada.

In addition, during the days prior to the start of the session, I declared any attempt to raise property taxes on Nevadans dead on arrival. I am proud to say that along with my Republican colleagues, we were successful in keeping that promise.

We also faced legislation that would have turned Nevada into a Sanctuary State by shielding violent criminal aliens and preventing law enforcement from doing their jobs in protecting our communities. Along with law enforcement agencies throughout Nevada, I stood up and fought this effort vigorously. I'm proud to say that these

harmful bills never made it out of the legislature.

Further, I worked last session to pass legislation to prevent lobbyists and special interests from wining and dining politicians and showering them with gifts. Despite an effort by Washoe Democrat Skip Daly to roll back this important new law, politicians will continue to be banned from accepting such favors and gifts.

There were also calls from Democratic leaders to further restrict our law-abiding citizens' from exercising their Second Amendment rights. Several pieces of legislation were proposed by the Democrats, yet not a single anti-gun bill made it out of the legislature.

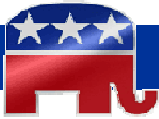
SUCCESS!

**Letter from
ATTORNEY
GENERAL ADAM
LAXALT
on Sanctuary Cities**

This morning, my office took crucial action aimed at combating a major threat to the safety of all

Nevadans — the ongoing problem of sanctuary cities in the State of California.

When discussing sanctuary cities, we should never forget that this is an issue of ensuring public safety, maintaining law and order, and making sure that our communities are safe places for our families and individuals. So let's be clear: Those who support the practice of allowing sanctuary cities to exist are launching a direct and outrageous assault on all three of those priorities.

And they're placing politics ahead of people. It's dangerous, and it needs to stop.

That's why I'm proud to join attorneys general from nine other states in filing an important friend-of-the-court brief that urges the dismissal of a California-based challenge to a federal-government executive order on sanctuary cities.

Because California is right next door, its sanctuary cities pose a genuine danger to Nevadans — particularly given those cities' refusal on some occasions to detain illegal aliens with violent criminal histories, releasing them

instead into communities where they have no right to be.

Fortunately, Nevada policymakers — including legislators, sheriffs and municipal leaders — have wisely and consistently rejected this absurd and reckless approach. But make no mistake: The practice of allowing sanctuary cities to exist right in a neighboring state not only undermines the rule of law; it also threatens the safety of our own people here in Nevada.

The federal executive order aims to uphold our national immigration laws by denying federal grants to local jurisdictions that “willfully refuse” to comply with those laws (except in cases where necessary for law-enforcement purposes). Multiple California cities are challenging the order, and the legal battle continues today.

The unlawful actions of these California cities cannot be allowed to stand. They pose a clear and direct threat to public safety here in Nevada, and that's why it was so important that my office take action on this crucial issue.

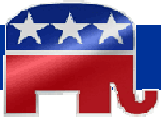

Why I'm a Republican

I grew up in a bi-partisan household. My father, born of Hungarian immigrants, was staunchly conservative. He believed that with hard work and the freedoms this country affords, we could achieve our goals. My mother was a southern Democrat, but rarely engaged in political discussions. When it came to politics, I listened to my Dad.

I grew up on the east coast in a middle-class suburb of Philadelphia. My father rode a train to work downtown. He selflessly devoted his life to providing for his 5 children. My mother taught piano to make ends meet.

The basic conservative principles I learned from my father were: limited government, lower taxes and promotion of, not competition with, private industry. Government is here to serve the people, not handcuff them.

I worked in both private industry and the public sector. I returned to work when my children entered elementary school. The economy wasn't doing too well, so I felt fortunate to be hired as an entry-level programmer for a Bay Area municipality. The vast majority of city workers were on the liberal side. They sought bigger government and more taxes. I was always striving for just the opposite. As I worked my way up the ranks, I looked for ways to save the taxpayers' money and get the best value. I remember going out on my lunch hour to shop for lightly used office furniture for my staff because the offerings through the city's purchasing department were in my mind just too extravagant. I was responsible for a volume purchase of computer

equipment when computers were more expensive than they are today. I pushed for the ability to buy equipment from a Texas manufacturer whose equipment was just as reliable, but far less expensive than brand x which was the "standard." I handled my budget of the taxpayers' money as carefully as I did my own.

I have to admit, I wasn't particularly interested in politics for much of my life. I started attending Incline Village General Improvement District (IVGID) meetings soon after I moved here. I was curious about what a General Improvement District really is. It didn't look or act like any government I had ever known. But it is government and as I have learned it violates conservative principles at every opportunity. It appears to have a strongly entrenched liberal philosophy. IVGID's lavish spending of taxpayer's money (largely ignoring the use of public bidding), seeming endless expansion into new "businesses" that compete with the private sector, and refusal to lower fees after paying off bonds were the reason that fees were increased in the first place – a triple threat of a liberal mindset.

I feel so privileged to work alongside the engaged and informed women of IVCBRW who oppose the ongoing shenanigans of our local government agency, and are continually involved in state and national issues that threaten our conservative values. As we have seen from the recent state legislative session, we have our work cut out for us there, too. If we stand united, and get out the truth, we can and will make positive change in our government at all levels.

As we celebrate our Nation's birthday and the freedoms we enjoy, let's work together to keep those freedoms in place.

KEEPING YOU INFORMED

The following information, provided by IVCBRW member and spells out the serious complications of the Parasol Building Proposal controversy.

Concerns Regarding Parasol Building Proposal

Over the last couple months the Parasol Building Proposal controversy has sparked a lot of concern from Incline Village residents. Numerous residents attended the May IVGID meeting, and 45 residents wrote letters to the Incline Village General Improvement District (IVGID) board, only two were favorable.

The June 15, 2017 *Bonanza* article on the Parasol building was very insightful. The information in the article that was most concerning was the operating costs. ***It cost Parasol between 3.6 million per year and 8.1 million per year to operate the Parasol building!***

There are a couple other points, not included in the article that should be pointed out. According to the March 10, 2017 fact sheet, the IVGID board estimated the cost of a new office building as 4.2 million. So why consider purchasing the Parasol building for 5.5 million? That is an extra 1.3 million dollars! Even that 4.2 million might be a rather high estimate. There is an office building across the street from the Parasol building, with adequate space for IVGID, for sale for 1.2 million.

Another issue that hasn't been explained thoroughly is that extra space in the Parasol Building can't be rented out to businesses because of the deed restrictions. In fact the deed restrictions may not even allow Parasol to sell the building to IVGID. Currently there has been no

Preliminary Title Report as pointed out by Matthew Dent at the last IVGID meeting.

According to Cliff Dobler, another concern that many residents have is that the IVGID board is continuing to spend thousands of dollars evaluating the Parasol Building Proposal. The only two trustees who have spoken out against this are Matthew Dent and Tim Callicrate.

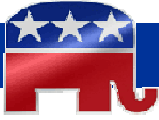

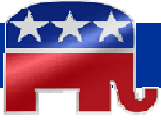
