PRESIDENT'S MESSAGE



This past month was enlivened by two major Republican Party events, the Nevada Federation of Republican Women's Spring Board and Membership Meeting being the first. There, we learned that the Federation is ahead of where it was at this time last year in total membership, 575 members versus 534 last year. We were

advised to focus on retention of members especially; and one suggestion was to charge non-members who attend our meetings five or ten dollars extra, to encourage them to join. Other clubs have found this to be a useful incentive.

Another highlight of the Federation meeting was a presentation by our own Yolanda Knaak, who is both our Legislative Chair and the Legislative Chair of the Nevada Federation of Republican women. Yolanda described the effort underway by the left to effectively eliminate the Electoral College, and thus the influence of the less-populated states that are not on either the East or the West Coast, on the selection of our president. It is essentially a "workaround" of the provision in the Constitution establishing and empowering the Electoral College. So far, nine states and the District of Columbia have already approved the "National Popular Vote Electoral Compact." These nine states and the District of Columbia account for a total of 165 electoral votes. The Compact is pending in eight other states that account for a total of 97 electoral votes. If States controlling a total of 270 electoral votes sign this compact, the election of the president will be by popular vote only and the Electoral College will be eliminated in practice from the election of the president. Mind you, I would expect this to be the subject of an epochal lawsuit that would end up at the Supreme Court, but who knows how it would turn out?

The second major Republican Party event this past month was the Washoe County Republican Party Convention on April 7th. The 154 delegates to the convention worked hard and harmoniously and accomplished a lot. They approved three primary changes to the Washoe GOP's bylaws and several other consequent adjustments to other parts of the bylaws. First, the number of standing committees was reduced to lessen the possibility of duplication of efforts; for example, the Voter Registration Committee and the Precinct Organization Committee were folded together to form a new Field Operations Committee. Next, the treasurer's job description was updated. Thirdly, the party's Executive Committee was reduced from 32 to 16 members to increase its efficiency.

The new Executive Committee will include the four elected officers of the party, the immediate past chairman (or chairwoman), the Nevada Federation of Republican Women's president if she lives in Washoe County, five at-large members elected by the membership of the Central Committee, and five more at-large members also elected by the Central Committee from a slate of nominees submitted by the recognized Republican clubs, one nominee per Club.

The convention delegates also elected the new Washoe County Republican Central Committee members, as well as delegates to the Convention of the Nevada state GOP; and overwhelmingly approved the revised party platform for 2018.

We can look forward to our May 8th Republican Candidates' Forum featuring all the GOP candidates that will appear on our primary ballot. So if you are wondering whom you should vote for in the primary, be sure to come to the GOP candidates forum!



he Nevada **Republican** Partv has filed a complaint against Congresswoman Jacky Rosen (who is expected to be the Democratic candidate for the U.S. Senate from Nevada). The complaint was filed with the Federal **Election Commission** and asks the Commission to investigate Rosen for accepting illegal campaign contributions. The complaint stems from an ongoing defamation

lawsuit filed against Rosen and her authorized campaign committee in November 2016 during Rosen's campaign for the House of Representatives. Rosen hired an army of lawyers from two different high-end law firms to defend her interests, yet to date neither firm has been substantially paid for its services.

Simply put – Rosen and her campaign evidently accepted 16 months of free or nearly free legal services that would usually cost thousands or even hundreds of thousands of dollars. These are enormously excessive in-kind donations that clearly violate campaign finance laws. To quote Nevada GOP Executive Director Greg Bailor, *"This complaint shows that Jacky Rosen was engaging in wildly inappropriate behavior even before she took office, so it's no surprise that her short time in Congress has been defined by a series of reckless and self-serving decisions."*

In other news, Rosen announced that she will campaign with Jane Fonda, who is notorious for her activism against those Americans who fought in the Vietnam War. Washoe County GOP chairman Michael Kadenacy, himself a Vietnam veteran, has this to say: "As a Vietnam veteran, I am deeply disturbed and personally offended that Jacky Rosen is joining forces with Jane Fonda, who proudly shamed and ridiculed me and the many warriors with whom I proudly served during the Vietnam War. Rosen's behavior shows reckless disregard not just for Vietnam Veterans, but for all the countless men and women who have answered the call of duty and risked their lives to keep our nation safe and strong. Jacky Rosen should be ashamed of herself."

Ampaign finance in the United States is the financing of electoral campaigns at the federal, state, and local levels. At the federal level, campaign finance law is enacted by Congress and enforced by the Federal Election Commission (FEC), an independent federal agency. Although most campaign spending is privately financed, public financing is available for gualifying candidates for President of the United States during both the primaries and the general election. Eligibility requirements must be fulfilled to qualify for a government subsidy, and those that do accept government funding are usually subject to spending limits. Races for non-federal offices are governed by state and local law. Over half the states allow some level of corporate and union contributions. Some states have limits on contributions from individuals that are lower than the national limits, while four states (Missouri, Oregon, Utah and Virginia) have no limits at all.

California cities are rebelling against state sanctuary law, but how far can they go?

hat started late last month with a city council vote in the Southern California suburb of Los Alamitos has grown into a wave of dissent across Orange County that is sparking a new kind of resistance in the Trump era: Californians in revolt against their own state not the Trump administration.

At least 14 Southern California cities and two counties have passed ordinances, and in some cases filed lawsuits, against the state's controversial sanctuary laws that largely prohibit local and state authorities from cooperating with federal immigration officers.

"There is a Revolution going on in California," President Trump tweeted last week, as part of almost a solid week of taunting Gov. Jerry Brown over his plans to restrict the state's National Guard troops from enforcing federal immigration law at the border. "Soooo many Sanctuary areas want OUT of this ridiculous, crime infested and crimebreeding concept. Jerry Brown is trying to back out of the National Guard at the Border, but the people of the State are not happy. Want Security & Safety NOW!"

Five facts about the unauthorized immigrant population in the U.S.

 There were 11 million unauthorized immigrants in the U.S. in 2015, a small but statistically significant decline from the Center's estimate of 11.3 million for 2009.The Center's preliminary estimate of the unauthorized immigrant population in 2016 is 11.3 million, which is statistically no different from the 2009 or 2015 estimates because it is based on a data source with a smaller sample size and larger margin of error. Unauthorized immigrants represented 3.4 percent of the total U.S. population in 2015. The number of unauthorized immigrants peaked in 2007 at 12.2 million, when this group was 4 percent of the U.S. population.

Mexicans may no longer be the majority of 2. U.S. unauthorized immigrants. They made up half of all unauthorized immigrants in 2016, according to the Center's preliminary estimate, marking the first time in at least a decade that they did not account for a clear majority of this population. Their numbers (and share of the total) have been declining in recent years: There were 5.6 million Mexican unauthorized immigrants living in the U.S. in 2015 and 2016, down from 6.4 million in 2009. Meanwhile, the number of unauthorized immigrants from nations other than Mexico has grown since 2009, from 5 million that year to 5.4 million in 2015. Non-Mexicans numbered 5.7 million in the preliminary 2016 estimate, a total that was not statistically different from 2015. From 2009 to 2015, the number of unauthorized immigrants from Asia and Central America rose. Increases in the number from other countries have mostly offset the decline in the number from Mexico

3. The U.S. civilian workforce includes 8 million unauthorized immigrants, accounting for 5 percent of those

who were working or were unemployed and looking for work, according to separate Pew Research Center estimates. The 2014 number was unchanged from 2009 and down slightly from 8.2 million in 2007. The share of unauthorized immigrants in the civilian labor force was also down slightly from 2009 (5.2 percent) and 2007 (5.4 percent). Compared with their 5 percent share of the civilian workforce overall, unauthorized immigrants are overrepresented in farming and construction occupations (26 percent and 15 percent, respectively). In all industries and occupations, though, they are outnumbered by U.S.-born workers.

4. Six states account for 59 percent of unauthorized immigrants: California, Texas, Florida, New York, New Jersey and Illinois. But individual states have experienced different trends. From 2009 to 2014, the unauthorized immigrant population decreased in seven states: Alabama, California, Georgia, Illinois, Kansas, Nevada and South Carolina. In all of them, the decline was due to a decrease in unauthorized immigrants from Mexico. In six states, the unauthorized immigrant population rose over the same time period: Louisiana, Massachusetts, New Jersey, Pennsylvania, Virginia and Washington. In all of these but Louisiana, the increases were due to growth in unauthorized immigrant populations from nations other than Mexico. (In Louisiana, the overall increase was driven by an increase in Mexican unauthorized immigrants.)

5. A rising share of unauthorized immigrants have lived in the U.S. for at least a decade. About twothirds (66 percent) of adults in 2014 had been in the U.S. at least that long, compared with 41 percent in 2005. A declining share of unauthorized immigrants have lived in the U.S. for less than five years – 14 percent of adults in 2014, compared with 31 percent in 2005. In 2014, unauthorized immigrant adults had lived in the U.S. for a median of 13.6 years, meaning that half had been in the country at least that long. Only 7 percent of Mexican unauthorized immigrants had been in the U.S. for less than five years in 2014, compared with 22 percent of those from all other countries.

Reducing legal immigration from well over one million presently to 300,000 a year over a sustained period will allow America to more sensibly manage its growth, address its environmental needs, and maintain a high quality of life. In addition, to genuinely improve our immigration system, family-based immigration must be limited to spouses and unmarried minor children of green card holders.

Citizenship Matters

It's not about being against foreigners. All nations put their people first. If there's hard work to do in the world, they turn to the U.S.A.

The left hates President Donald Trump for many

reasons. One of the most important is because he really believes in America first. He doesn't just say it. He bases his policies on that principle – which shouldn't be controversial. It's nothing against foreigners. They put their people first. They don't provide the U.S. with "foreign aid." They don't protect America from foreign enemies. If there's dirty work to do in the world, they turn to Washington.

The Duty of Government

It's about time we were equally serious about taking care of our own. The first duty of the federal government — and states and localities too — is to protect and support Americans. The Preamble of the Constitution explains this. The federal government's purpose is to "insure domestic tranquility, provide for the common defense, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity." If we don't take care of ourselves no one else will.

The political foundation of our republic is citizenship. That means enjoying the benefits but also paying the price of being an American. Becoming a U.S. citizen is an honor. People all over the world desire it. And citizenship is important precisely because it brings full participation in U.S. society. Once you become a citizen — but only then — can you help decide what America is and will become.

Shrugging at Voter Fraud

So naturally only citizens should vote. But, sadly today that idea offends many Democrats. They see themselves as citizens of the world. To them it's not a problem if you come to America illegally. – And not a problem if you vote illegally. Thus, the Left, which includes once mainstream organizations such as the League of Women Voters, works hard to prevent us from learning how many illegal ballots are cast.

But the American Civil Rights Union has challenged that activity by filing federal lawsuits against numerous jurisdictions which have more people registered to vote than residents. Where 100-year-olds and 200-year-olds not only are registered but are actively voting; where people are registered in more than one state; and where non-citizens register and vote. Meanwhile election officials do little to nothing to remove them from the voter rolls.

Every Vote Matters

Four years ago, three professors at Old Dominion University estimated that at least 620,000 non-citizens were registered to vote nationwide. The number could be substantially higher. They concluded: "We find that some non-citizens participate in U.S. elections, and that this participation has been large enough to change meaningful election outcomes including Electoral College votes, and Congressional elections."

If you believe in democracy, these findings are disturbing. Consider Starr County, Texas. Decades ago, it helped make "Landslide Lyndon" Johnson's career in his first race for U.S. Senate. The local District Attorney, Omar Escobar, testified before the state legislature that current registration procedures were "an invitation to fraud."

Even small numbers of improper votes can have significant impacts. President Donald Trump carried the states of Michigan, Pennsylvania, and Wisconsin by especially narrow margins. Just .3 percent and 12,000 votes in the first. In Virginia one (yes, one) vote determined the outcome of a delegate contest last November. *That contest determined control of the entire legislative body*.

Proof of Citizenship Onerous?

The obvious solution is to require proof of citizenship to register to vote. Naturally, the Left calls such a requirement "onerous." Yet proof of citizenship, most obviously a birth certificate, needs only be procured

once. Anyway, the law should apply even if complying is difficult. The majority is cheated — betrayed, really — when illegal votes change the result of an election. Government has no more fundamental duty than to protect the integrity of the electoral process.

Unfortunately, a federal court previously blocked an attempt by Alabama, Georgia, and Kansas to add a citizenship requirement to the federal registration form. The form only requires that the registrant swear to be a citizen. Only Kansas was actively enforcing a state citizenship requirement. But that state's secretary of state, Kris Kobach, is now fighting a lawsuit brought by the ACLU (who else!?). The lawsuit claims it's illegal for the state to ensure that those registering to vote are doing so legally. The New York Times even celebrated when the federal judge refused to allow Kobach to introduce new evidence of improper registrations.

Eternal Vigilance

Critics of election safeguards argue that only a handful of cases of fraudulent behavior have been found. But these are the very people making it virtually impossible to determine the magnitude of the problem. Republicans need to focus on the upcoming election. The Democratic strategy is to use the courts to block election integrity and manipulate redistricting. It could give them victory.

Eternal vigilance is the price of liberty, Thomas Jefferson told us. It also is the only defense for free elections.

DNC Officials Tell Hillary Clinton They Want Their Money Back



Democrat officials want Hillary Clinton to give back \$1.65 million the Democratic National Committee (DNC) agreed to give her in exchange for her campaign email list and other supporter-prospecting resources.

The DNC made the deal with Clinton last year for the materials, but, Democrat leaders want her to refund the money, The Huffington Post reports: "In February 2017, the DNC agreed to pay Clinton's group Onward Together \$1.65 million for her campaign email list, analytics, donor data and related items, The Intercept reported on Wednesday. The cache of material was worth more than \$5 million; Clinton's campaign made an in-kind donation of resources worth \$3.5 million, and the DNC paid for the rest. "Now, a number of Democratic Party officials, including some state party chairs and DNC members, want Clinton to retroactively donate the campaign materials to the DNC and return the money that the party organ gave Onward Together."

Clinton should return the \$1.65 million "for the love of the party" and because it's "the Christian thing to do," DNC officials say. Clinton spokesman Nick Merrill says the DNC has more than gotten its money's worth from the materials.

Why an American Bought London Bridge

B orn on June 7, 1761, Scottish civil engineer John Rennie* was responsible for three important landmarks in central London – Waterloo Bridge, Southwark Bridge and London Bridge, which in an astonishing deal was sold to an American tycoon in 1968.

"London Bridge is falling down, falling down . . ." runs the popular children's rhyme. In the 1960s it wasn't actually falling down, but surveys showed that it was sinking by about 2.5cm every eight years. It would have to be replaced.

Enter Ivan Luckin, a member of the Common Council of the City of London who came up with what seemed a preposterous idea of putting the bridge up for sale. He said later: "They all thought I was completely crazy when I suggested we should sell London Bridge."

But Luckin's "crazy" idea was the answer to a prayer for American oil tycoon Robert P. McCulloch. He had spent millions buying more

than 16,000 acres of Arizona desert to establish a township. Then his business partner, CV Wood, who had planned and supervised the creation of Disneyland in California, mapped out what was to become Lake Havasu City.

It looked fine, but there was something missing: a major attraction; something to pull in visitors and literally put the town on the map. That's when McCulloch heard that London Bridge was up for sale. He jumped at the chance and paid \$2,460,000 for the historic bridge. It was dismantled stone by stone and all 10,276 numbered pieces were shipped through the Panama Canal to Long Beach, California, then carried on trucks to Lake Havasu for reassembly.

The bridge that McCulloch bought was officially New London Bridge, the foundation stone for which was laid in 1825 by "the Grand Old Duke of York" – formally known as Prince Frederick, Duke of York and Albany (1763–1827). It was designed by John Rennie but not constructed in his lifetime. The bridge replaced one that had stood since medieval times.

Soon after the sale rumors began that McCulloch mistakenly thought that he was buying Tower Bridge, the iconic combined bascule and suspension structure that has become a symbol of London and stands next to the Tower. Luckin denied this was the case.

The rumour is also dismissed in the book, *London Bridge in America* by Travis Elborough (Jonathan Cape), which tells the complete story. The author points out that McCulloch was a smart businessman and when he came to sign the sale documents he was



photographed on London Bridge with Tower Bridge in the background. The bridge now spans a man-made canal and forms the centerpiece of an English-style theme park that includes a mock-Tudor shopping mall. It has become Arizona's secondbiggest tourist attraction, after the Grand Canyon. Travis Elborough says the bridge seems "curiously

right" where it is. "Under a blazing sun and a pure cerulean sky, its reconstructed neoclassical arches appear strikingly refined . . . and far more convincingly Greco-Roman than they could ever have done in London."

* John Rennie was born June 7, 1761 in Phantassie, East Lothian, Scotland and died October 4, 1821, London, England. Rennie was a Scottish civil engineer who built or improved canals, docks, harbors, and bridges throughout Britain.



Does My Vote Really Count?



It is a myth that your vote doesn't count. Despite the electoral college electing the President directly, every vote counts. It just counts in complex ways that differ by election, state, and region. In other words, your vote is always counted (unless voter fraud occurs), but the ways in which your vote affects the outcome of a given election depends on many factors.

Factors that affect your vote include competition in your state and region, what you are voting on, who you are voting for, and whether we are talking about the general election in which the competitive Presidential election (including the primary and caucus) takes place alongside countless other races, or the "off-year" or mid-term elections (where there is less competition).


