
GOP Candidates for IVGID Forum



A Law of Life: Sowing and Reaping

There's a story of two Stanford students who many years ago arranged for the world-famous concert pianist I. Jan Paderewski to come to the university to give a concert. He agreed to do so for a fee of \$2,000. After the concert the boys discovered they had raised \$1,600, not enough to pay the fee. They went to Paderewski, apologized, and offered an I.O.U. for the balance. Whereupon Paderewski tore up the check, expressed his regret that the boys had fallen short, then said, "You pay your expenses with that money, keep 10 percent for yourselves, and send me whatever is left."

In later years Paderewski returned to his native Poland and, following World War I, Poland selected him to thank the President of the United States for the massive assistance from the Americans who had provided life-saving aid. The President was **Herbert Hoover**, who told

Paderewski he had been one of those two Stanford students whose debt the great concert artist had forgiven so long before.

Why I will Vote "NO" on Question 3 on November 6th – and You Should Too!

uestion 3 reads: "Shall Article 1 of the Nevada Constitution be amended to require the Legislature to provide by law for the establishment of an open,

competitive retail electric energy market that prohibits the granting of monopolies and exclusive franchises for the generation of electricity?"

On the surface, it sounds like a winning proposal. I know I prefer more choices. I'm a firm believer that a competitive market creates better products. And if you've followed me at the legislature you know I've spent many sessions fighting against a system that favors monopolies and oligopolies. I'm all for embracing reforms that will ensure affordable energy choices to every Nevadan, and I'm excited that technology is quickly changing the way power can be delivered and we must be able to quickly adapt to changing times.

That being said, my biggest problem with the way Question 3 (Q3) is currently written is the fact that it wants to etch an amendment into the Nevada Constitution. My friends, there is a time and place for amending constitutions, and this is not it. The dumping of concrete verbiage into our Constitution could make the issue of deciding future matters regarding energy usage *less* efficient for all Nevadans, since it would take SIX YEARS to amend the constitution again if needed to correct any bad unintended consequences of O3.

Let me give you some historical perspective on how the current structure to protect rate payers was enacted. During 2001 when energy shortages were the norm, Assembly Bill 661 was passed to allow mega-consumers of power to exit the grid and purchase from other sources if they agreed to pay an "exit fee." The exit fee was vital because initially, the infrastructure required to connect these large consumption users to the grid had to be built and maintained to meet demand, and if these large users suddenly left the power provider, the initial cost incurred to connect them to the grid was never going to be recouped unless users exiting the grid agreed to cover the

cost incurred to initially tap into the grid; or unless the remaining rate payers (you and me) absorbed the cost of allowing those exiting to escape their obligation.

So that you and I wouldn't get stuck paying somebody else's bill, AB661 obligated mega-users who had required all that initial infrastructure cost to agree to pay a fee decided by the Public Utilities Commission. This apparently was viewed as a fair deal by some who decided to pursue other energy alternatives, including MGM and Wynn Resorts, who paid proportional shares of exit fees to ensure that you and I would be protected. Some power-guzzlers, however, didn't like the rules, and balked at the exit fees that were required to protect the smaller rate payers. Any guesses who they might be?

That answer becomes obvious when you study the backers of a group calling itself "Nevadans for Affordable Clean Energy Choices" that is funding all those advertisements currently promoting the passage of Q3. Upon searching, I discovered that the ad buys really didn't involve any run-of-the-mill you -and-me type "Nevadans" at all, but consisted mainly of two large corporations that donated nearly \$20 million within a few weeks' time — Las Vegas Sands and Switch. These happen to be two of the largest consumers of power in the state who also have major disputes with the way the current arrangement was originally structured by lawmakers in 2001.

"But Don, isn't it possible that passage of Q3 could benefit all rate users?" Tough to gauge. I've read through different lengthy studies to determine an outcome, and the best answer is that plenty of uncertainty is on the line. In my search for neutral opinions, I consulted a report released this month by the Guinn Center for Policy Priorities titled, Restructuring the Electricity Market in Nevada? Possibilities, Prospects, and Pitfalls. The Guinn Center also published a 21-page voter information guide that can walk you through Q3 at a quicker pace, and both publications are available on their website.

"NO" on Question 3

To sum up their findings in a nutshell, the Guinn Center finds that "evidence on the effect of restructuring (energy choice) on electric prices is mixed and inconclusive. It is impossible to predict what will happen to electricity rates (and a ratepayer's electricity bill) should Question 3 pass.... [S]ome customers benefit from energy choice, while others encounter adverse effects." Are you prepared to roll the dice to amend our Constitution? I'm not. Realize this, folks -- of all the states that have implemented the restructuring of energy markets, not one of them ever did so through a constitutional amendment. Good thing for them, because several of the states that did implement restructuring had to repeal provisions either wholly or in part due to destructive unintended consequences that arose during the revamping process (and it would take six years to repeal or change this proposed constitutional amendment).

So I'll be voting **no** — and I hope you will too — on a constitutional amendment that would risk the livelihoods of the majority of rate payers, because **it doesn't take a constitutional amendment to offer rate payers more choices and healthy competition**, and because there is no current constitutional crisis pertaining to electrical power in Nevada. Truth be told, Nevada rate payers now enjoy electricity rates that are far **below** the national average. Prudence is the word for the day, and instead of jack-hammering unnecessary amendments into our Constitution, I will instead work to advocate for legislative measures to find safe and affordable energy options for ALL Nevadans.


Nevada Federation of Republican Women 4th in Nation in Membership Retention

Louisa Catherine Johnson Adams, 1775-1852



ouisa Adams is the only First Lady born outside the United States (until First Lady Melania Trump, who was born in Novo Mesto, southeastern Slovenia) and did not come to this country until four years after she had married

John Quincy Adams. Political enemies sometimes called her English. She was born in London to an English mother, but her father was an American.

The pleasure of moving to the White House in 1825 was dimmed by the bitter politics of the election and by her own poor health. She suffered from deep depression. Though she continued her weekly "drawing rooms," she preferred quiet evenings reading, composing music and verse, and playing her harp. The necessary entertainments were always elegant, however; and her cordial hospitality made the last official reception a gracious occasion although her husband had lost his bid for reelection and partisan feeling still ran high.

The Adamses could look back on a secure happiness as well as many trials when they celebrated their 50th wedding anniversary at Quincy in 1847. He was fatally stricken at the Capitol the following year; she died in Washington in 1852.

Hannah Hoes Van Buren, *1783-1819*



ousins in a close-knit Dutch community, Hannah Hoes and Martin Van Buren grew up together in Kinderhook, New York. In 1807, the childhood sweethearts were married.

Apparently their marriage was a happy one, though little is known of Hannah as

a person. Van Buren omitted even her name from his autobiography; a gentleman of that day would not shame a lady by public references. A niece who remembered "her loving, gentle disposition" emphasized "her modest, even timid manner." Her health failed apparently from tuberculosis, and not yet 36 she died on February 5, 1819. Her husband never remarried; he moved into the White House in 1837 as a widower with four bachelor sons.

Anna Tuthill Symmes Harrison, 1775-1864



nna Harrison was too ill to travel when her husband set out from Ohio in 1841 for his inauguration, at age 65, she was well acquainted with the rigors of frontier journeys. On April 4, exactly one month after his inauguration, he died, so Anna

never made the journey. She had already begun her packing when she learned of her loss.

She had grown up a young lady of the East, completing her education at a boarding school in New York City. A clandestine marriage on November 25, 1795, united Anna Symmes and Lt. William Henry Harrison, an experienced soldier at 22. The family moved to the farm at North Bend during the threat of war in1812. There, she heard the news of her husband's landslide electoral victory in 1840, home-loving Anna said simply: "I wish that my husband's friends had left him where he is, happy and contented in retirement."


